

MEMORANDUM OF UNDERSTANDING FOR IMPROVING STUDENTS' EMPLOYABILITY THROUGH INTERNSHIPS

PREAMBLE

WHEREAS, **Banasthali Vidyapith** (an institution deemed to be university, notified by the Government of India vide its notification No. F.9-6/81-U.3 dated 25 October, 1983 under section 3 of the UGC Act, 1956 and having its address at Banasthali Vidyapith P.O Banasthali -304 022, Rajasthan, INDIA (hereinafter referred to as BV)

AND

WHEREAS, **NANDINI FINTECH SERVICES PRIVATE LIMITED**, a company was established in 2017 (CIN: U74999RJ2017PTC057561) and having its branch office at Nandini House, 14VP, Agra-Bombay Road, Indore is engaged in Advisory, Consultancy and Academic Research (hereinafter referred to as NF)

INTEND to improve employability by facilitating internships for students of Banasthali Vidyapith in domains like but not limited to Financial Literacy, Research, Business Management, Integrating Simplification, Innovation, Entrepreneurship etc.

NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both parties BV and NF hereby agree to sign a memorandum of understanding (MoU).

ARTICLE-I: SCOPE OF THE MoU and INTERACTION

This **MoU** details the modalities and general conditions regarding collaboration between **BV** and **NF** for internship of students in areas of advisory related to engineering, design, pharmacy, business management, incubation, entrepreneurship etc. without any prejudice to prevailing rules and regulations of **BV** and **NF** and without any disregard to any mechanism evolved and approved by the competent authorities under Govt. of India in so far as such mechanism applies to **BV** and **NF**. The areas of cooperation can be extended through mutual consent, if needed.

The internships to students will be offered by NF and both parties will allot a mentor for desired outcomes. Upon successful completion of the internships, a certificate will be issued to the candidate by NF following due process as per rules and regulations of both the parties.

ARTICLE-II: ROLE OF BV and NF

The contributions are mentioned, however **BV and NF** shall mutually discuss and decide the roles in the largest interest students' employability.

BV would facilitate process of recruiting interns by sharing relevant information and requirements of **NF**. Also, **BV** will update **NF** with window frame during which students will be available for internship. The Training and Placement Cell members will remain in touch with **NF** for smoother coordination.

NF would share their requirement pre-hand and provide relevant opportunities to the students. **NF** will also ensure to update **BV** whenever the student joins as intern. It will be encouraged by **NF** that mentors from both parties interact in the best interest of the students. **NF** will facilitate student in preparing the report that will be submitted by the student for obtaining requisite credits. After successful completion of the internship, certificate will be issued by **NF** to the student. The nature of internship can be paid/unpaid, however, preference should be given to paid internships.

ARTICLE-III: EFFECTIVE DATE AND DURATION OF MoU

- a) This **MoU** shall be effective from the date of its signing by competent authorities of all the three parties.
- b) The duration of the **MoU** shall be for a period of 3 years from the effective date.
- c) During its tenancy, the **MoU** may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the **MoU** will not in any manner affect the interests of the students/faculty/researchers who have been admitted to pursue the research the **MoU**.
- d) Any clause or article of the **MoU** may be modified or amended by mutual agreement between **BV and NF**.

ARTICLE-IV: CONFIDENTIALITY

During the tenure of the **MoU** the parties – **BV and NF** will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this **MoU** for any purpose other than in accordance with this **MoU** or statutory requirements.

BV and **NF** shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to other parties without written approval of the disclosing party or use such confidential information for any use other than intended under this AGREEMENT or PROJECTS.

ARTICLE-V: AMENDMENTS

Any amendment and/or addenda required to be made on mutual consent basis to this MoU shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the MoU and have the effect of modifying the MoU to the extent required by such amendment or addenda.

ARTICLE-VI: RESOLUTION OF DISPUTES

Would be done based on mutual discussion.
