

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement made on Twenty First day of August, 2021 by and between

BANASTHALI VIDYAPITH, an Institution deemed to be University, notified by the Government of India vide its notification no. F.9-6/81-U.3 dated 25 October, 1983 under Section 3 of the UGC Act, 1956 and having its office at Banasthali Vidyapith P.O. Banasthali Vidyapith-304022, Rajasthan, through its Secretary, Professor Dharma Kishore (Which expression shall unless repugnant to the context thereof, mean and include its successors and assigns) of the First Part (hereinafter referred to as BV).


AND

WHEREAS M/s. Mountain Eagle Security and Allied Services (P) Ltd., Regd. Office: 709, K-2 Block, Mahipalpur Extn., New Delhi-37 and Branch Office: 47-B, Lohia Colony, Bajri Mandi Road, Vaishali Nagar, Jaipur (Raj.) (hereinafter referred to as MESAAS is a Security Company in Delhi as well as in Jaipur catering the security and facility needs to the esteemed clients across the country.

AND WHEREAS recognizing the need of having Security personnel's as per the requirement of BV.

Now it is hereby agreed between the parties as under: -

1. MESAAS will provide 30 Security Guards (Civil) to the Banasthali Vidyapith and deploy them at the places mentioned in Annexure-I.
2. The Security Guards shall be well trained, disciplined, obedient, having faultless character, teetotalers and physically fit to discharge their duties in a proper manner.
3. BV will pay Rs. 5950/- per month for the Security Guard (Civil) for eight hours duty per day.
4. MESAAS will submit the Character Certificate of their Security Guards on deployment alongwith two passport size photographs not more than six months old.
5. MESAAS will provide additional strength of security personnel's at a short notice and should keep a leave reserve ready.
6. Banasthali Vidyapith can terminate any particular worker deployed by MESAAS who will leave the premises within 24 hours and suitable replacement will be made by MESAAS within two days.
7. The validity of the contract will be from 1st September, 2021 to 31st August, 2023.
8. The instructions given by the BV or any representative appointed by it will be followed by the security staff strictly.
9. No residential accommodation for the security staff will be provided by BV.
10. This contract can be terminated by giving one month's notice without assigning any reasons whatsoever.
11. MESAAS will provide a copy of security agency license of the authority concerned.
12. MESAAS will observe and confirm to all rules and regulations of the local authority concerned and comply with all statutory regulations specially relating to Labour Law, Provident Fund, ESI and other laws in any way relating to Security



Agencies. It will be the sole responsibility of MESAAS to adhere to all the provisions in this regard and Banasthali Vidyapith will stand indemnified in toto.

13. MESAAS will pay the taxes, and other levies, if any in respect of Security Agency to the Government or any local authority.
14. It is also hereby agreed that in case Banasthali Vidyapith is not satisfied with the services provided by MESAAS the Vice-Chancellor shall be at liberty to impose any penalty or recover the cost paid.
15. In case of any dispute on payments or other matters of the contract between MESAAS and BV, the decision of the mutually agreeable arbitrator will be final and binding on both of us.
16. The parties hereto unconditionally and irrevocably agree to submit to the exclusive jurisdiction of the competent courts in Tonk only with regard to any question or matter arising out of this agreement and any other documents that may be executed by the parties hereto or any of them in pursuance hereof or arising herefrom.


And in the confirmation of the above Agreement, the parties have set their hands at Banasthali on the day and date mentioned hereinabove.
