

LibSys Software Description

The library has been using LibSys Software since Feb.2005. Presently the updated version Libsys4 (Rel 6.3) is being used by all the libraries of Vidyapith. The software supports all activities relating to acquisition, cataloguing, circulation and serial control. Additionally, it provides an advanced user-friendly OPAC interface to access all library materials on single click.

The Acquisition system covers initiation of titles for ordering, approval, placing of orders, receiving materials, invoice processing, accessioning and many more.

The Cataloguing system maintains a title-in-process file of all items that are accessioned and catalogued data. In addition, this system covers catalogue maintenance, holding updates etc.

The Circulation system supports front desk operations such as check-in, check-out, renewals, reservation, membership renewal. It provides bar-code based issue-return system.

The Serials system provides for new subscription, renewal, recording of current and achieved collections etc.

OPAC (Online Public Access Catalogue) provides access to the library's holdings through various catalogues and indexes such as author catalogue, title catalogue, subject catalogue, classified catalogue, publisher index.

Presently, the software is holding all the bibliographic details of all libraries including books, journals, theses, dissertations, reports etc. All the circulation activities is based on bar-code tag system. All the libraries has also been set-up the OPAC terminals which help the users to find out their desired materials easily.

- Balance Rs. 1,18,500/- after one year of the date of installation provided the software has been successfully working in the proceeding period.
