Complaint made by Ms. Sudiksha Kont

The matter came into the cognizance of the Vidyapith administration when the local police officials visited the campus of Vidyapith to probe into the matter. Soon after this the Anti-Ragging committee of the Vidyapith took up the matter and spoke to the complaining student as well as to the student against whom the said complaint was made and it was found that both the students are pursuing same course and are classmates and also share same room in hostel. Both the students were counselled and after pacifying the issue between them the complainant student Ms. Sudiksha Kont gave in writing to Vidyapith regarding having no complaint or dispute against Ms. Palak Sharma and also she does not want any further action in reference to the complaint made by her (Annexure-I).

Ms. Sudiksha Kont had also sent a mail to you not to take any further action with regard to complaint registered by her as the problem has been resolved by the Anti-ragging committee of the Vidyapith and she does not want any further investigation in this regard (Annexure-II). The local police visited our campus and submitted their report (Annexure-III). In the report they did not find the matter even remotely connected to ragging.

Accordingly, the Vidyapith has considered the matter closed in view of the such compromise.
